- \* I am aware that the International Students & Scholars Office (ISSO) is concerned with any matter that relates to my stay in this country.
- \* I also understand that, as an F-1 or 1-1 visa holder; I must purchase and maintain health insurance through United Health Care as stated on my SEVIS I-20 or DS-2019.
- \* I know that I must keep my passport valid six months into the future (unless exempt).
- \* I must also carry a full course of study (12 credit hours for Undergraduate; 8 hours for Graduate and PhD, unless exempt).\* The ISSO must be contacted if I plan to: (1) drop below minimum credit hours; (2) extend my stay when nearing completion of my current degree program;
- (3) transfer schools (at least 30 days before); (4) seek work ON or OFF campus (if eligible); (5) apply for optional practical training BEFORE or AFTER completion; (6) leave Oakland University (7) process documents needed to maintain my stay; (8) report change of address within 10 days of moving; (9) discuss any and all matter's that affect my favorable status in this country; or (10) seek assistance in applying for extension of stay after my degree or program completion.
- \* Iunderstand that "employment" means rendering service on either part-time or full-time basis for compensation (financial or otherwise) including selfemployment (i.e. independent contractors). NO EMPLOYMENT IS PERMITTED WITHOUT THE PERMISSION OF THE INTERNATIONALSTUDENTS & SCHOLARS OFFICE'S APPROVAL.
