WHEREAS, Aisha Zanib entered Oakland University as a student from Rochester Adams High School in Rochester Hills, MI to pursue a major in Clinical and Diagnostic Sciences in the School of Health Sciences; and

WHEREAS, Ms. Zanib demonstrated academic excellence by maintaining a 3.93 grade point average; earning Deans and President's List recognition for 8 semesters; working as an Oncology Nursing Assistant at Corewell Health in Royal Oak, MI and a Medical Scribe at Rochester General Surgery in Rochester Hills, MI; and by being recognized by her professors for her diligence and significant dedication to learning; and

WHEREAS, Ms. Zanib demonstrated campus leadership by helping to establish the Undergraduate Research Society, serving as Vice President for two-consecutive years and assisting her peers in creating numerous research opportunities with faculty; working with Dr. Rebecca Malatesta in the Department of Psychology to create, "The 5 Mile Difference," a mentorship program for low-income students designed to highlight the stark statistical high school graduation rates and reading proficiency between two neighboring schools that are located 5 miles apart from each other; and

WHEREAS, Ms. Zanib dedicated herself to research by working on a three-year thesis project through the Department of Clinical and Diagnostic Sciences in the Biochemistry and Endocrinology Breast Cancer Lab, investigating the impacts of endocrine-disrupting compounds on breast cancer mechanisms, leading the publication of several abstracts and a recent manuscript; and

WHEREAS, Ms. Zanib demonstrated the characteristics of responsible citizenship by serving as President of the Asian and Pacific Islander Vote (APIA) of Michigan, a nonprofit organization that provides direct services to communities in Southeast Lower Michigan such as voter registration, resource distribution, mental health support, and youth leadership; and
