## **ACCOUNTING AS AN UNDERGRADUATE MAJOR**

Accounting is the process of identifying, measuring, recording and communicating the economic events of an organization and is often said to be the “language of business.” Accountants apply their skills in areas such as auditing, cost management, financial analysis, information systems, management, policy and taxation. These services are provided to large and small businesses, governmental units and not-for-profit entities. Accounting professionals are individuals capable of doing more than maintaining sets of accounting records as they focus on analyzing and measuring business activity, processing that data into reports and communicating the information to decision makers. Accounting is often the pathway to top management of a corporation.

Oakland University’s School of Business Administration is one of only five schools in Michigan to hold elite AACSB- International accreditation in both its business and accounting programs.

### **MAJOR REQUIREMENTS FOR BACHELOR OF SCIENCE IN ACCOUNTING**

To fulfill the requirements for the major in accounting, students must be admitted to major standing, complete the core program, and a minimum of 32 credits, as specified below, with a grade of C or better in each major course.

The OU accounting student is prepared for the CPA exam and a career in accounting. Many public accounting firms and corporations recruit OU accounting students.

Students planning to sit for the CPA Examination should be aware that the state of Michigan (and many other states) requires a minimum of 150 credit hours and specific accounting courses to become a Certified Public Accountant. During your undergraduate program, options for completing the 150 hours will be discussed. One option is to complete the Master of Accounting degree program. Students are encouraged to seek advising from the Director of Accounting for the Master of Accounting Program if they are considering this option.
